1 Treatment as a "professional investor" 「專業投資者」之待遇

I hereby declare that I am an individual having a portfolio of not less than \$8 million at the relevant date when any one or more of the following are taken into account 本人/吾等謹此聲明本人為個人客戶在考慮以下任何一項或多於一項時,擁有的投資 組合在有關日期不少於\$8,000,000 -
